# IX. Executive Director's report— Michelle Bronson **Budget Updates:**

We are pleased to share we were approved for the second year with United Way of Tulare County! They granted us \$7,524, a little less than last year, but still we are thrilled to receive their funding. This is for the same program as last year, and this time we have to increase our number of families from 10 to 15, so we are developing a plan of action on our marketing efforts.

We were turned down by State Farm for their community grants, which we had hoped to apply towards our Youth Employment Services (YES!). We will try again next year.

We received \$10,000 from Levine W. Foundation towards our Raise the Roof campaign! We are thrilled with and deeply appreciative of their generous support of DHHSC. We are now at \$27,526, more than halfway, but I am determined to fundraise as much as possible this year to finish the goal. The longer it takes to meet the goal, the slower the momentum and people become less interested in supporting our fundraising efforts for the roof. We want to move fast while it is still new. I have already emailed our Raise the Roof campaign letters to each Rotary Club in our Fresno/Clovis area, and other than Fig Garden Rotary Club that recently donated \$1,500 to us, Fresno Rotary contacted us and asked for us to fill out an online grant application. The funny thing is they've already expended their funds for this fiscal year, so they've asked me to date the application to July 1<sup>st</sup>, when they start the new fiscal year. I've already submitted the application and requested paperwork, so keep your fingers crossed!

We finished our Whitney Foundation \$25,000 match and will submit all the needed paperwork by Friday, April 13<sup>th</sup>. We met with Ellen Bush, the executive director, on April 3<sup>rd</sup>, and she was very pleased with our LEAD program, meeting Joshua Blanco, seeing our services, and how we met our fundraising goal. The paperwork is the last thing needed, and once the Whitney board approves, we will receive their \$25,000 check. We had to raise the match first prior to getting their check.

## **Agency Updates:**

Please send positive thoughts and prayers my way tomorrow (Wednesday, April 11<sup>th</sup>) at 2:30 p.m. as I will be testifying on behalf of the California Coalition of Agencies Serving the Deaf and Hard of Hearing (our Deaf Coalition) regarding our budget item augmentation. One Deaf NorCal community member from another country and I are the two people testifying for our need for additional funds, and I will do my utmost best to represent all of us well.

Our staff members have been working hard on preparing for Family Day scheduled for April 14<sup>th</sup>, YES! Career Awareness Fair on May 2<sup>nd</sup>, and Deaf Prom on May 12<sup>th</sup>. We have also begun advertising the NTID/DOR camp for Deaf and Hard of Hearing students that will be at Fresno State University during the week of June 24<sup>th</sup>-29<sup>th</sup>. This is an all-expense paid STEM camp with an emphasis on agriculture and irrigation. We are excited about this opportunity for D/HH high school students. As you can see, we have many events coming up for D/HH high school students, and we want to ensure each goes smoothly and successfully.

- TS Can you discuss more about the camp. Is it available for Juniors or Seniors? SJ Sure, DOR selects the students. The VR determines which students to go.
- X. Fundraising Chair report Jill Nolen It's now a good time to have restaurant fundraiser. We will do either Pieology or Blaze Pizza. The other one will be Habit Hamburger place. Michelle had suggested to have both on the same time. The goal is to have it on either one of two Saturdays in May, and we're hoping for May 5<sup>th</sup>.

So we've thought of Subway or Snacks or the Snow Cones. The group that sold Snow cones last year made a lot of money. We don't normally allow other vendors, but

that was a good idea. We're not sure if we should allow them again, but it's something to think about. JSW – We don't have to decide tonight.

JSW – It appears that that September 27-30 weekend may be a good weekend. Susan – We did set up a women's conference that is every two years. It's June 2<sup>nd</sup>. The theme is "Navigating the woods of life." We will have a group of panelists who will share about their successes in life. Also for CCRID, they have their own Pizza fundraiser. It's Mountain Mikes on North Cedar (and Shepard) and it will be all day. You must bring the e-mail printed copy or bring your phone to make sure the 30% of proceeds go to CCRID. The money that we're collecting is to help support the roof fund.
